Thank you for choosing Mellifera Photography. These Terms & Conditions help make sure we both understand what to expect when booking a photography session.

1. Booking & Payment

A 50% booking fee is required to secure your photography session and reserve your chosen date and time.

The remaining 50% balance is due 2 days before your scheduled session.

Your booking is not confirmed until the required booking fee has been received.

By making a booking, you agree to these Terms & Conditions.

2. Cancellation & Rescheduling

If you need to cancel or reschedule your session, please contact Mellifera Photography as soon as possible.

Cancellations made within 5 days of the scheduled session may result in the booking fee being retained.

Rescheduling is subject to availability, and every effort will be made to find an alternative date that works for you.

Nothing in these terms is intended to exclude or limit your rights under the Australian Consumer Law.

3. Weather & Unexpected Circumstances

For outdoor sessions, Mellifera Photography may recommend rescheduling if weather conditions are unsafe or unsuitable for photography.

If Mellifera Photography needs to reschedule your session due to severe weather, illness, emergency or another circumstance outside reasonable control, we will work with you to arrange an alternative date.

4. Session Timing

Please arrive on time for your scheduled session.

If you arrive late, your session may need to finish at the originally scheduled time, which may reduce the amount of photography possible.

Mellifera Photography will always aim to provide a relaxed and enjoyable experience while making the most of your allocated session time.

5. Image Delivery

Your finished edited images will normally be delivered through an online gallery within approximately 7–10 days of your session.

If your gallery is going to take longer than 10 days, you will be notified.

The number of images delivered will depend on the type and length of your session.

Raw, unedited or unfinished images are not provided.

6. Copyright & Personal Use

Copyright of all photographs remains with Mellifera Photography.

Your completed images are provided to you with a licence for personal, non-commercial use.

You are welcome to print, share and enjoy your photographs for personal purposes.

Images may not be altered, sold, used for commercial purposes or submitted to publications, competitions or third parties for commercial use without prior written permission from Mellifera Photography.

7. Sharing Your Images

You are welcome to share your finished images on social media for personal purposes.

When sharing, crediting Mellifera Photography is appreciated.

Please do not apply filters or significant alterations to the images that change the way the photographs were intentionally edited.

8. Portfolio & Social Media Use

Mellifera Photography may use selected images from your session for portfolio, website, social media, advertising and other promotional purposes.

If you do not wish your images to be used publicly, please let us know before your session.

Your preference will be respected.

9. Travel

Mellifera Photography's standard service area is within 40 km of Brisbane, Queensland.

Additional travel outside the standard service area may incur a travel fee, which will be discussed with you before your booking is confirmed.

10. Image Gallery & Backups

Your images will be supplied through an online gallery.

Mellifera Photography makes reasonable efforts to maintain a backup of your delivered images for 6 months after delivery.

We strongly recommend that you download and safely store your images once your gallery has been delivered.

Mellifera Photography cannot guarantee the availability of images after the 6-month backup period.

11. Privacy

Any personal information provided to Mellifera Photography will be handled respectfully and used for purposes connected with your photography booking, communication, delivery of services and business administration.

Personal information will not be sold to third parties.

12. Australian Consumer Law

Mellifera Photography operates in accordance with applicable Australian laws, including the Australian Consumer Law.

These Terms & Conditions do not exclude, restrict or modify any consumer guarantee, right or remedy that cannot legally be excluded.
